

ARTICLES OF INCORPORATION OF R & P SERVICES, INC.



In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME:

The name of the corporation is R & P Services, Inc.

ARTICLE II. TERM OF EXISTENCE

The corporation shall have perpetual existence starting five (5) days prior to the filing of these Articles of Incorporation.
