ARTICLES OF INCORPORATION



We, the undersigned, subscribers to the Articles of Incorporation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be GLENN BERROJO, INC., Its principal place of business shall be 926 Curlew Road, Dunedin, Florida 34698.
