Name

The name of the corporation is MCJC, Inc.

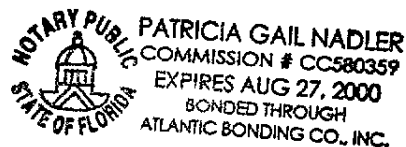
