# ARTICLES OF INCORPORATION OF

## ARTICLE I. - NAME

The name of the corporation is **FLORIDA CITRUS NURSERY, INC.** The address of the principal office of this corporation shall be 304 Carmela Drive, Frostproof, Florida 33843, and the mailing address shall be Post Office Box 1318, Frostproof, Florida 33843.

#### ARTICLE II. - DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of the State of Florida.
