ARTICLES OF INCORPORATION

OF

BRIDGETTE'S ART STUDIO, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this Corporation is: BRIDGETTE'S ART STUDIO, INC.

The duration of the Corporation is perpetual.
