By these Articles of Incorporation the incorporator forms a corporation for profit under Florida Law.

**ARTICLE I**

The name of this corporation is CST Technical Solutions, Inc.

**ARTICLE II - TERM**

This corporation shall exist perpetually. Corporate existence shall commence on February 14, 2000.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to transact any and all lawful business for which Corporations may be incorporated under Chapter 607 of the Florida Statutes.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue one thousand (1,000) shares of common stock with par value of \$1.00 per share.

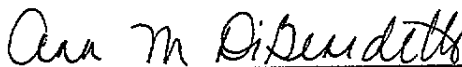
