

**I.
Name**

The name of the Corporation is Big Buck Fabrications, Inc., hereinafter referred to as the "Corporation."

**II.
Purposes**

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

**III.
Principal Office and Registered Agent**

The principal office of the Corporation is Rt 2 Box 201 Altha, Florida 32421. 


