

#### ARTICLES OF INCORPORATION

Of

### Slip Shield, Inc.



The undersigned, acting as incorporator of a corporation under Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

The name of corporation is Slip Shield, Inc., having its place of business at 2821 East Commercial Blvd., Suite 201, Fort Lauderdale, and FL. 33308.

#### ARTICLE II

The period of duration of the corporation is perpetual.

#### ARTICLE III

The purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.

#### ARTICLE IV

The corporation shall have the authority to issue 100,000,000 shares of Common stock at any given time, with par value of \$.0001 per share.

The corporation shall have the authority to issue 50,000,000 shares of Preferred non-designated stock at any give time, with par value of \$.0001 per share.

The Board of Directors shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at the Board of Director's Meeting, with no less than majority of the vote casted by the Board members. Regardless of number of the board of directors members, each board member shall have one vote.

#### ARTICLE IX

The power to adopt, alter, amend or repeal Bu-Laws shall be vested in the Board of Directors.

#### ARTICLE X

The preemptive right of any holder is determined by the ratio of the authorized shares of Common stock held by the holder of all shares of Common stock currently authorized.

Pursuant to Florida Statute Section 607.167(10, the effective date of the commencement of corporate existence is the 7<sup>th</sup> day of February, 2000, which is the date of subscription and acknowledgement of the Articles of Incorporation. Said Articles of incorporation are to be filed within five days after such date.
