ARTICLES OF INCORPORATION

OF

DESTIN POINTE MANAGEMENT, INC.

The undersigned, desiring to form a corporation under Chapter 607, the Florida General Corporation Act, does hereby certify:

Article 1 - Name

The name of this corporation (which is hereinafter called the "Corporation") shall be:

Destin Pointe Management, Inc.

and the principal place of business will be 480 Gulf Shore Drive, Destin, FL 32541 and the mailing address will be 111 Center, Suite 1600, Little Rock, AR 72201.

Article 2 - Commencement and Duration

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.
