**ARTICLES OF INCORPORATION**  
**OF**  
**TAMPA WIRE AND INSULATION, INC.**

**ARTICLE I - NAME**

The name of this corporation is:

TAMPA WIRE AND INSULATION, INC.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of filing and acknowledgment of these articles.

**ARTICLE III - PURPOSE**

The corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 7500 shares of One Dollar (\$1.00) par value common stock.

**ARTICLE V - PREEMPTIVE RIGHTS**
