OF

THE UNDERSIGNED INCORPORATOR OF THESE ARTICLES OF INCORPORATION IS A
NATURAL PERSON COMPETENT TO CONTRACT AND HEREBY FORM A CORPORATION
FOR PROFIT UNDER THE GENERAL CORPORATION ACT AND OTHER LAWS OF THE
STATE OF FLORIDA.

ARTICLE I. NAME

THE NAME OF THIS CORPORATION IS WELLS OFFICE SUPPLY, INC.

ARTICLE II. COMMENCEMENT

THIS CORPORATION WILL EXIST EFFECTIVE MARCH 1, 2000.

ARTICLE III. DURATION

THIS CORPORATION IS TO EXIST PERPETUALLY.

ARTICLE IV. PURPOSE

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF TRANSACTING ANY OR
OR ALL LAWFUL BUSINESS.

ARTICLE V. CORPORATION POWERS


