The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

- 1. <u>Name and Address</u>. The name of the Corporation shall be ANTELOPE CONTRACTING CORPORATION. The mailing address of the Corporation shall be 455 Alternate 19 South, Apartment 57, Palm Harbor, Florida 34683.
 - 2. <u>Duration</u>. The Corporation shall have perpetual existence.
- 3. <u>Purpose</u>. The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and of Florida.
- 4. <u>Capital Stock</u>. The corporation is authorized to issue 1,000 shares of common stock, at a par value of ONE (\$1.00) DOLLAR per share.
