### ARTICLES OF INCORPORATION

## SPI RESOURCES, INC.



The undersigned Incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I NAME

The name of the corporation is SPI Resources, Inc. (the "Corporation").

## ARTICLE II STREET ADDRESS

The street address of the Corporation is 329 Mallard Road, Weston, Florida 33327.

# ARTICLE III CAPITAL STOCK

The number of shares of capital stock that the Corporation is authorized to issue is One Thousand (1,000) shares of common stock, par value \$.01 per share (the "Common Stock").
