ARTICLE I

Corporate Name and Principal Office

The name of this corporation is STAFFORD HUGHES, INC. and its principal office and mailing address is 9603 Sunnyoak Dr., Riverview, Florida 33569.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on February 18, 2000.

ARTICLE III

General Nature of Business

By-Laws


