**ARTICLE I. CORPORATE NAME.**

The name of this corporation is **GEORGE C. MOSELEY SPREADING SERVICE, INC.**

**ARTICLE II. ADDRESS OF PRINCIPAL OFFICE.**

The address of the principal office of this corporation is Rt. 2, Box 369, Lake City, FL 32024. The mailing address for the corporation is P.O. Drawer 2759, Gainesville, FL 32602.

**ARTICLE III. NATURE OF BUSINESS AND POWERS.**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE IV. CAPITAL STOCK.**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock with a par value of \$1.00.

**ARTICLE V. TERM OF EXISTENCE.**

This corporation shall have perpetual existence commencing upon filing of these articles.

#### ARTICLE XII. RESTRICTIONS ON TRANSFER OF STOCK.

Shares held by the initial shareholders listed above may not be resold or otherwise transferred to other persons unless first offered to the remaining shareholders or to the Corporation. The price and terms of which, and the time within which, those shares may be offered and sold shall be further specified by written agreement among all of the shareholders and this corporation.

#### ARTICLE XIII. STOCK ENDORSEMENT.

Each share of stock issued subject to these bylaws shall be endorsed as follows:

"Transfer, pledge, hypothecation, sale, assignment, gift or other disposition of this stock is restricted by an article of the bylaws of this company, a copy of which is on file at the office of the corporation."

ARTICLE XIV. INDEMNIFICATION.

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

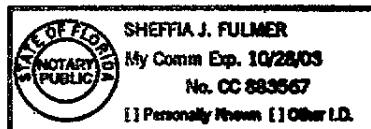


