ARTICLES OF INCORPORATION
OF
Eastbay Mortgage Services, Inc.

ARTICLE I

The name of the corporation is Eastbay Mortgage Services, Inc.

ARTICLE II

Its initial registered office and principal office in the State of Florida is 8805 N Mulberry St in the City of Tampa, County of Hillsborough. The name of the initial registered agent at such address is Bruce D. Henry.

ARTICLE III

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE IV

The total number of shares of capital stock that the corporation shall have authority to issue is 1000, all of which are to be common stock with a par value of \$.01 per share. The total No of voting shares that the Corporation shall have the authority to issue is 1,000, no par value.

ARTICLE V

The name and address of the incorporator is: Bruce D. Henry 8805 N Mulberry St, Tampa FL 33610

ARTICLE VI

The corporation is to have perpetual existence.

ARTICLE VII

The private property of the stockholders shall not be subject to the payment of corporate debts.

ARTICLE VII

Subject to the laws of the State of Florida, the following provision are adopted for the management of the business, and for the conduct of the affairs of the corporation and for defining, limiting, and regulating the powers of the corporation, the directors, and the stockholders:

(a) The books of the corporation may be kept outside the State of Florida at such place or places as may from time to time be designated by the Board of Directors.

(b) The business of the Corporation shall be managed by its Board of Directors and the Board of Directors shall have power to exercise all the powers of the Corporation, including (but not limited to) the power to create mortgages upon the whole or part of the property of the Corporation, real or personal, without any action of or by the stockholders, except as otherwise provided by statute.

(c) The number of Directors constituting the initial Board of Directors is one(1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than one(1). The name and address of each initial Director of the Corporation is as follows:

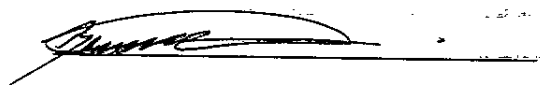
