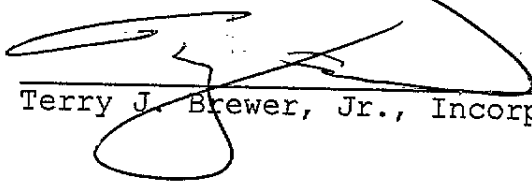
TERM OF EXISTENCE

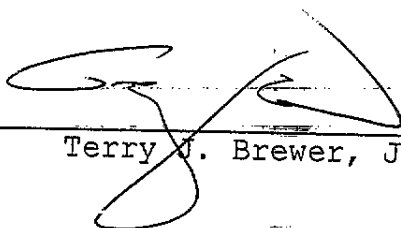
