The undersigned, being an Accredited Estate Planner and a duly licensed insurance agent and securities agent doing business in the State of Florida, acting as incorporator of a corporation under the Florida Professional Service Corporation And Limited Liability Company Act, Florida Statutes Chapter 621, hereby adopts the following Articles Of Incorporation:

ARTICLE I. NAME
