We have a dispute over charges with First Hialeah Community Credit Union on a Request done by us on March 2002. Asking for reimbursement of money deducted by the bank errors, on the statement. We receive a letter back from the bank on April 19, 2002 stating that they have no errors, and as a courtesy they will refund us \$275.00 in fees and that will close the case.

Since they close the case, which was unfair I we did a search through the account from the date we open the account (08-17-01) until now and we have found a numerous of errors in the statement!

A number of Non-Sufficient fund, which on the agreement with our account the official of the bank inform me was that the checks that I write or try to get cash in the at the branch, they will only cash them if there is money available meaning only available not on hold, but if the check will be presented by another bank to bank they will pay the check even if the money is on hold. But if the check will be presented by another bank or similar institution on a bank to bank transaction they will pay the check even if the money is on hold or because a check is not clear but yet it was deposited. A number of errors were found on this investigation, and when we had all this documentation. And when we hand in the Claim. The bank had merge and the new owner of the account which is Government Employees Credit Union of Florida, refer us to the NCI for any claim prior of the merge here are the errors detailed one by one on each occurrence detail that reflect my account balance differences.
