The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:


ARTICLES OF INCORPORATION


- SIX:** The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under Florida law.
