In September I received a notice of Resolution or Revocation for my business, Construction Ahead Builders, Inc. I responded to this notice with a letter dated October 21, 2004, where I explained that I had submitted my annual report form along with a check for \$150.00 dated March 4 2004. You responded to this letter on November 1, 2004 acknowledging receipt of the document and check, but the document was not filed because it was missing the FEI Number. You mentioned in your letter that the document was sent back to me on March 16, 2004 for corrections, however I never received it. The only correspondence I received from you after I filed the document was the notice of Dissolution or Revocation in September.

Ever since then I have been trying to solve this problem and somehow you keep sending the document back saying I failed to make the corrections requested. In January 2005, the second time you returned the document, I spoke to one of your reviewers and she told me all I had to do was send a check for \$150.00 for 2005 filing. She said corrections for 2004 were already done. I immediately proceeded to do as I was told and I send in a check for \$150.00 (Check #11184 dated January 20, 2005) for 2005.
