

ARTICLES OF INCORPORATION OF  
1441 SR 7, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be 1441 SR 7, INC.

The principal address of the corporation at the time of incorporation is 1441 N. State Road 7, Margate, Florida 33063.

ARTICLE II. DURATION

The duration of this corporation is perpetual, unless dissolved according to law.

Corporate existence shall commence on the date these Articles of Incorporation are filed by the Department of State.
