ARTICLE XIII - AMENDMENT

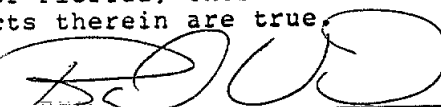

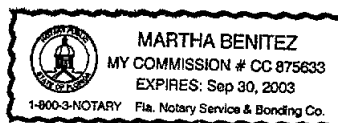
