ARTICLES OF INCORPORATION
OF

THE HARRIS FOUNDATION, INC.

The undersigned Incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the Corporation shall be: The Harris Foundation, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be:
