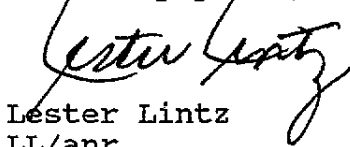

ARTICLES OF INCORPORATION
OF

Article I - Name

The name of this corporation is **APPLIANCE NOW, INC.**

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these Articles are filed with the Secretary Of State.

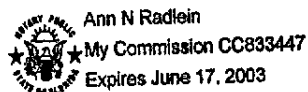

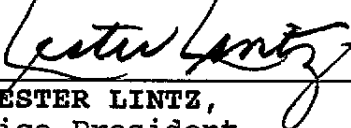

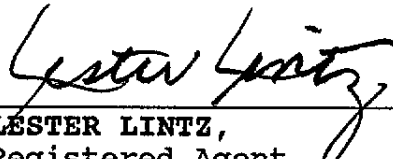
