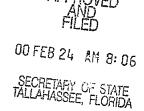

# ARTICLES OF INCORPORATION OF JME HOMES,INC.

The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE
