The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.



to vote thereon, unless all of the directors and all of the stockholders sign a written agreement manifesting their intention that a certain amendment of these Articles of Incorporation be made.


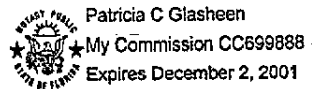


