NAME AND ADDRESS

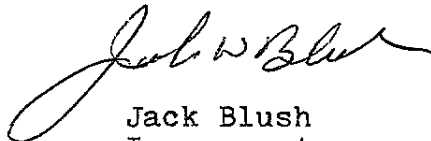

The corporation shall indemnify all offices and directors, and former officers and directors, to the fullest extent permitted by law as the law now exists or may be amended hereafter.

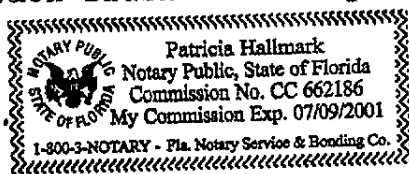
