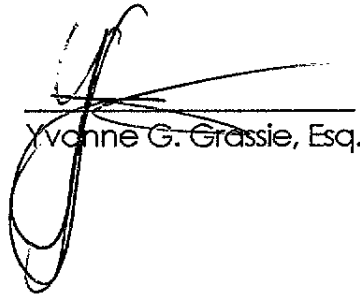

**ARTICLES OF INCORPORATION  
OF  
JUAN JOSE BONAVERA, P.A.**

The undersigned, desiring to form a professional corporation in accordance with Chapter 621 of the Florida Statutes for the practice of law, does hereby adopt the following Articles of Incorporation.

**ARTICLE ONE  
NAME**

The name of the corporation is JUAN JOSE BONAVERA, P.A. (the "Corporation").

**ARTICLE TWO  
PURPOSE**

The purposes for which the Corporation is organized are as follows:

1. Primarily to engage in the specific business of the practice of Veterinary Medicine as a professional association;
2. To engage generally in the business of a professional association engaged in the practice of veterinary medicine, as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;
3. To engage in such other business as may be authorized or permitted by Chapter 621 of the Florida Statutes.

**ARTICLE THREE  
PRINCIPAL OFFICE**

The principal office of the Corporation shall be located at 3060 Aviation Avenue, Miami, Florida, 33133.

**ARTICLE FOUR  
REGISTERED AGENT**

The registered agent for the Corporation shall be Juan Jose Bonavera, D.V.M., 3060 Aviation Avenue, Miami, FL 33133.

**ARTICLE FIVE  
DIRECTORS**

The Corporation shall initially have one director, which number may be increased or decreased pursuant to the bylaws of the Corporation but shall never be fewer than one. The initial director shall be Juan Jose Bonavera, D.V.M., 3060 Aviation Avenue, Miami, FL 33133.

**ARTICLE SIX  
STOCK**

The aggregate number of shares of stock which the Corporation is authorized to issue is 1,000 shares of Common Stock, par value \$.01 per share.

**ARTICLE SEVEN  
INITIAL CAPITAL**

The amount of stated capital with which the Corporation shall begin business is Ten Dollars (\$10.00).

**ARTICLE EIGHT  
DURATION**

The duration of the Corporation shall be perpetual.
