ARTICLES OF INCORPORATION

OF

The Undersigned, for the purpose of forming a Professional Corporation under the Florida Business Professional Service Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1.0 NAME AND ADDRESS

The name of the Professional Corporation is: Dr. Andre Salas, P.A. The principal office and mailing address is 1700 Wells Road, Suite 25, Orange Park, Florida, 32073.

ARTICLE 2.0 DURATION

The duration of the Professional Corporation is perpetual.

ARTICLE 3.0 PURPOSE

The purpose for which the Professional Corporation is organized is to render professional legal services through members, officers, employees and agents who are persons duly licensed to practice law in the State of Florida.

ARTICLE 4.0 SHARES


