ARTICLE I. NAME

The name of this Corporation is Computer 2000 International, Inc., and the address is 6831 Narcoossee Road, Unit 51, Orlando, Florida, 32822.

ARTICLE II. TERM OF EXISTENCE

This Corporation shall exist perpetually.

ARTICLE III. NATURE OF BUSINESS

This Corporation may engage or transact in any or all activities or businesses permitted in the laws of the United States of America and the State of Florida.

ARTICLE IV. CAPITAL STOCK

No shareholder shall have the right to accumulate his or her votes at any election for the Board of Directors nor any other matter of this Corporation.


ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT
