# ARTICLES OF INCORPORATION OF FLOWERS BY CAROLYN INC.

SEQUENCE SECTION

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE I - NAME

The name of this corporation is FLOWERS BY CAROLYN INC.

#### <u>ARTICLE II - PURPOSE</u>

This corporation is organized for the purpose of transaction any and all lawful business permitted under the laws of Florida.

### ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue five hundred shares of \$1. Par value common stock, which shall be designated as "Common Shares".
