Article I

The name of the corporation is "Labrador Groves, Inc."

Article II

The corporation has the authority to issue not more than one million shares of common stock that together have unlimited voting rights and that together are entitled to receive the net assets of the corporation upon dissolution. The stock will have no par value. The stockholders shall have preemptive rights.

Article III
