ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is ANYTIME GOURMET, INC., and the street address of the initial principal office is 2515 Willow Lane, Lynn Haven, Florida 32444. The mailing address of the corporation is 2515 Willow Lane, Lynn Haven, Florida 32444.

ARTICLE II - PURPOSE
