ARTICLE ONE**NAME**

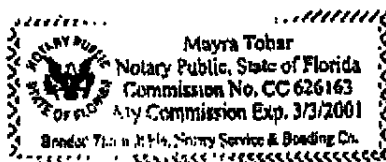


