BY-LAWS



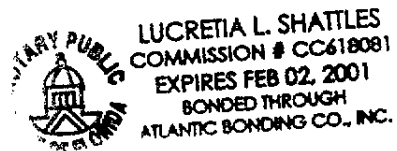
