ARTICLE I. NAME AND ADDRESS

ARTICLE II. DURATION AND COMMENCEMENT

This corporation shall exist perpetually and shall commence on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE III. PURPOSES

This corporation is organized for the following purposes:

- 1. To own, operate and manage a woman owned minority construction based business with emphasis on hazardous environmental clean-up, site preparation and levee and canal construction in Florida, other states of the United States and in foreign countries.
