The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

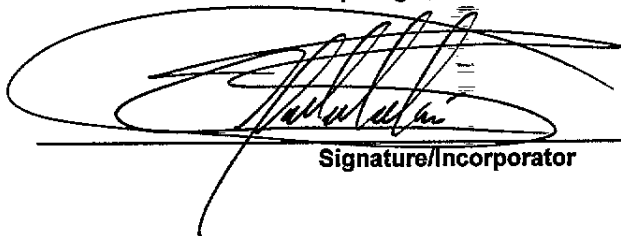
ARTICLE 1. The name of the corporation shall be Gabal Technical Services Corporation.
