ARTICLE I -- NAME

The name of this corporation is: **A.R.M. TILE, INC.**

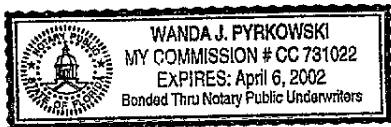
