The undersigned, incorporator, for the purpose of forming a corporation or der the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is SECURITY CONSULTANT & MANAGEMENT GROUP, INC., hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The period of duration of the Corporation shall be perpetual unless dissolved according to law.
