**ARTICLES OF INCORPORATION  
FOR

The undersigned incorporator to these Articles of Incorporation hereby form a corporation (the "Corporation"), under the laws of the State of Florida as follows:

**ARTICLE I**

Name

The name of the corporation shall be:

**ARTICLE II**

Term of Existence

The date when the corporate existence shall commence shall be the filing of these Articles of Incorporation in the Office of the Florida Department of State, and the Corporation shall have perpetual existence thereafter.

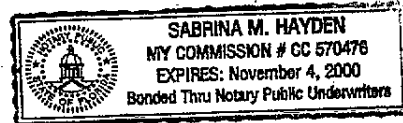
