1. Be it amended that Article V of the original Article of Incorporation has been changed.

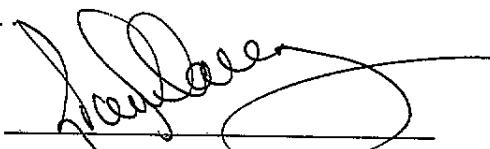
