

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I

PURPOSES


This corporation is organized to transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.




