

ARTICLES OF INCORPORATION

OF

SOUTHERN SAND-STARR, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLES ONE: NAME

The name of this corporation shall be: SOUTHERN SAND-STARR, INC.

ARTICLE TWO: NATURE OF BUSINESS

The general purpose for which this corporation is initially organized is to own and operate a business for health care billing for medical professionals, and for the further purpose of engaging in any activities or business permitted under the laws of the United States and Florida.

As such stock will qualify for all rights and privileges of Section 1244 Stock.
