ARTICLES OF INCORPORATION OF NAPOLEON'S TAILOR, INC.



The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

Napoleon's Tailor, Inc.

ARTICLE II

The corporation's principal place of business shall be located in the City of Fort Lauderdale, Florida, Broward County, Florida, and its mailing address shall be as follows:
