#### ARTICLES OF INCORPORATION

**OF** 

Harrison Marshall Construction, Inc.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I. NAME

The name of this corporation is:

Harrison Marshall Construction, Inc.

#### ARTICLE II. NATURE OF BUSINESS

The corporation may engage in any activities or business permitted under the laws of the Unice State and of the State of Florida.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time shall be as follows:

One thousand (1,000) shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be as fixed by the board of directors, and may take the form of services rendered, cash, property or any other form deemed satisfactory by the board of directors.

#### ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation will begin business shall not be less that five hundred dollars (\$500.00).

#### ARTICLE V. TERM OF EXISTENCE

The corporation is to exist perpetually.

#### ARTICLE VI. ADDRESS


