ARTICLE I - NAME

The name of this Corporation is C & S Construction Management Services, Inc.


ARTICLE IX - INDEMNIFICATION

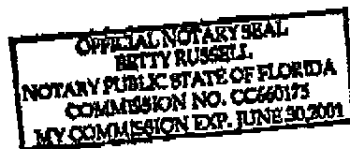


