

We are enclosing a completed Application for Restatement of corporate status for Spoto's PGA, Inc. We have updated the information listed on the form. We respectfully request you consider the circumstances listed herein and waive the additional Restatement Fee.

Our Company operates a restaurant in Palm Beach County. I have been the bookkeeper since the end of April 2001. It is my understanding that the Florida Department of State had sent the Annual Report renewal applications earlier in the year. However, they never crossed my desk. Due to the poor economy, we have had a number of different individuals work for us. I believe the Annual Report forms may have been inadvertently discarded by one of those employees who did not understand what the forms were for.

Our Company is struggling to keep afloat and maintain employment for our staff in a very difficult economic market. Despite our financial troubles, we take pride in our compliance with the various taxes and financial reporting rules that we must comply with. The failure to file our Annual Report timely was an oversight that was entirely inadvertent. We ask you to consider our late filing as "reasonable cause" and allow us to pay the original fee of \$150. The savings would be meaningful to us. Our check for the \$150 is enclosed.
