ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is JOE'S OCEAN MARKET, INC. The principal office and mailing address of this corporation is: 900 N. Ocean Drive, Hollywood, FL 33019.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

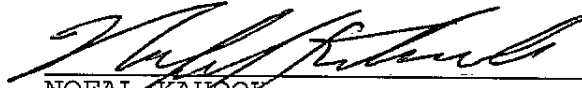
ARTICLE IX - INDEMNIFICATION

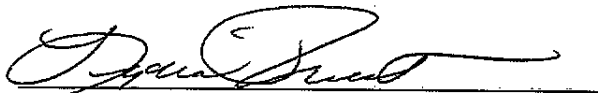
