# ARTICLES OF INCORPORATION OF BP OF ORLANDO, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I

# NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

The name of the Corporation is **BP OF ORLANDO, INC.** The principal place of business of the Corporation is **1424 SHELTER ROCK RD, ORLANDO, FL 32835.** The duration of the Corporation is perpetual.

## ARTICLE II

# REGISTERED OFFICE AND AGENT

The address of the registered office in the state of Florida is 1424 SHELTER ROCK RD in the city of ORLANDO in the County of ORANGE. The name of the registered agent at such address is HASMUKH PATEL.

# ARTICLE III

## CORPORATE PURPOSE, POWERS AND RIGHTS

- 1. The nature of the business to be conducted or promoted and the purpose of the Corporation are to engage in any lawful act or activity for which Corporation may be organized under the Business Corporation Act of Florida.
- 2. In furtherance of its corporate purpose, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Business Corporation Act of Florida.
